### Has this happened to you?

- You're harassed by neighbors at your apartment complex because you are transgender;

- You're asked if you are transgender when you request admission to temporary housing;
- You're denied access to a homeless shelter because of your sexual orientation or gender identity;
- You're given a notice of eviction because you stood up for your rights to fair housing;
- You're denied admission into a seniors' residence because of your LGBT status;
- You're told your family is ineligible for public housing because of your sexual orientation;
- Your self-identification of gender is not accepted by housing staff;
