FAIR HOUSING RIGHTS FOR SURVIVORS OF DOMESTIC VIOLENCE



Has this happened to you?

- Your landlord refuses to rent to you because you are or have been the victim of domestic violence or because you have rent assistance from Oregon Department of Human Services (DHS) or another agency;
- You are told you must pay for property damage done by your abuser;
- Your landlord refuses to promptly change your locks or allow you to change them;
- Your landlord refuses to release you from your lease or rental agreement;
- Your application for an apartment is turned down because being a victim of domestic violence shows up as criminal history;
- Your landlord uses a policy of "zero tolerance" against crime to evict you because you are a victim of domestic violence;
- You are evicted because you have repeatedly called the police because of domestic violence and neighbors have complained.
